### 4. FIRST AID MEASURES

#### Description of first aid measures

**General advice** Show this safety data sheet to the doctor in attendance. Immediate medical attention is required.

Inhaled corrosive substances can lead to a toxic edema of the lungs. Pulmonary edema can be fatal.

Causes burns. Corrosive to the eyes and may cause severe damage including blindness. Causes serious eye damage. May cause irreversible damage to eyes.
